This computer network gives police departments access to national databases maintained by the Federal Bureau of Investigation (FBI) and California's Department of Motor Vehicles (DMV), among others. The system also allows law enforcement agencies to deliver messages among one another.

CLETS information can only be accessed by authorized law enforcement and criminal justice personnel. Any information obtained from the system can be used for "official use" only.
