We are careful not to use the term reactive abuse when talking about how people respond to abuse. We consider this more "self defending behavior." We don't want to use the word "abuse" referring to a survivor's behavior because the survivor is not being abusive. It is not a dynamic happening "between" two parties, but always one exerting power and control over the other.
